2018 Management Success Shop Owner's Expo Rules and Regulations

Compliance with Laws: Exhibitor shall comply with all Federal, state, and local laws in place at the site of the Expo.

Approval of Promotion: Exhibitor agrees to refrain from promoting or endorsing any product not approved by Management Success, or to endorse any persons or companies in direct competition with Management Success in the auto/truck shop consulting field.

Insurance and Waiver: Exhibitor acknowledges that they are solely responsible for any possible loss, theft or damage to their display or equipment, and have business/ interruption and property damage insurance covering such losses. Exhibitor will maintain liability insurance in full force and effect at all times while at the Expo site, and agrees to provide proof of same to Management Success upon request.

Safety Regulations: Exhibitors specifically agree to follow all provisions of the local fire code and applicable federal, state and local regulations.

Exhibit Space Assignment: Space is assigned at the discretion of Management Success, and will only be assigned when payment in full is received.

Exhibitor Conduct: Exhibitor agrees to conduct themselves in an orderly manner, to abide by the rules and regulations of the Expo site, to be considerate of other exhibitors and comply with requests made by Management Success.

Force Majeure: In the event that any outside emergency (fire, earthquake, terrorist attack, etc.) prevents the Expo from being held, Management Success may retain all or a portion of Exhibitors rental fee to cover prepaid expenses up to the time of the cancellation.

Assembly and Disassembly: Exhibitor agrees to set-up and take down their tables/displays according to the instructions and schedules set by Management Success in order to avoid any interruption to the Expo, or inconvenience to other exhibitors, organizers, and/or attendees.
